- 7 That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation and examination byelaws and the circulars issued by the Board from time to time. The School undertakes to abide by the provisions contained in the affiliation & examination byelaws directions issued from time to time and the law of the land.
8. That The school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc, with respect to the school and staff of the school.

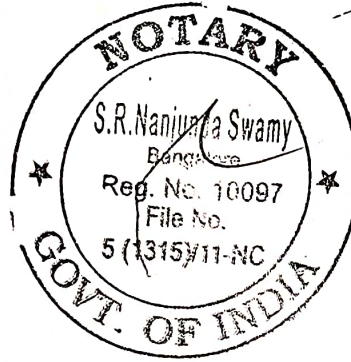

- 14 That the school shall strive to make efforts for conservation of environment.
- 15 That the school will ensure that the school fulfills all essential requirement before applying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules as given in the affiliation byelaws or notified from time to time
16. That the school not start CBSE pattern classes without submitting a commencement certificate to the effect that the school has complied with all the conditions imposed by CBSE and the post-affiliation conditions contained in affiliation byelaws along with general rules,
