The number of sections and students shall be restricted as per the actual facilities in the school.

For class rooms of size less than 500 sq feet the enrolment shall be 0.08 X size of class rooms in sq feet

Important Notes: 1. The total number of section of the school shall be restricted to 14 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws. 2. The school has submitted vernacular copy of Recognition Certificate with the application. However the notarized translated copy of Recognition Certificate in the name of St. Joseph English Higher Primary School and has been uploaded under mandatory disclosure on school's website. The school is directed to renew the recognition certificate as per NOC. 3. The school has submitted Society Registration Certificate In the name of The Immaculate Conception Education Society with the application. However, the name change w.e.f. 27.08.2003 in the name of The Immaculate Conception Society has been uploaded under mandatory disclosure on school's website. 4. The school has submitted the land document with the application. However, the land certificate for 8498 sq. mtrs. (17180 sq. mtrs. mentioned in the application) has been uploaded under mandatory disclosure on school's website. The school has uploaded a letter dated 18.03.2022 in the mandatory disclosure that the land area mentioned in the application has been entered by mistake. 5. The school has submitted Fire Safety recommendations with the application. However, the Fire Compliance report no. 861/CFO/BWZ/2022 dated 24.02.2022 has been uploaded under Mandatory Disclosure in the School's website. Thus the school is directed not to remove the certificate from the website. 6. The school is required to set-up Composite Science Lab and Maths lab as per dimension given in Affiliation Bye-laws. 7. The school is required to implement the Policy of inclusion for the CWSN and appoint Special Educator Teacher as per Board norms, 8. The school is required to develop the playground. 9. The school is required to procure more computers to maintain computer to students' ratio i.e. 1:20 10. The school is required to renew all the mandatory certificates from time to time. 11. The school is directed not to remove all the documents in the mandatory disclosures including sl. no.2 to 5 and the videography link in future. School is required to appoint wellness teacher as per affiliation bye laws.
